



# SCEP Annual Report 2012

The Office of Statewide Clinical Education Programs

## Community-Based Medical Education Division

The **Office of Statewide Clinical Education Programs (OSCEP)** is a unit of the Carver College of Medicine's administration. Established in 1974, OSCEP has principal responsibility for developing and coordinating collegiate outreach programs for medical education and community service. This continuous effort for nearly four decades has resulted in a high level of visibility and trust for the College in Iowa communities.

OSCEP comprises three divisions:

- Community-Based Medical Education
- Community Services
- Tracking Systems/Workforce Analysis

This report summarizes select 2011-2012 OSCEP activities.



- Administered \$2.2 million of **state grants**.
- Maintained **affiliation relationships** with the six UI-Affiliated Regional Medical Education Centers.
- Provided administrative and educational support for eight residency programs training 154 residents across **the Iowa Family Medicine Residency Network**.
- Organized and administered an intensive two-day course in **Advanced Life Support in Obstetrics (ALSO)** for 60 residents in Iowa family medicine residencies.
- Planned and coordinated 11 **faculty development workshops** at the six UI-Affiliated Regional Medical Education Centers, serving community-based clinical faculty.
- Coordinated four UI **Community Teaching Scholars** workshops for 38 participants at the Carver College of Medicine.
- Published semi-annual issues of **Around the State**, a newsletter for community-based medical educators with a readership over 800 across Iowa.
- Placed 142 first-year medical students in 284 **clinical shadowing experiences** with primary care physicians within a 40-mile radius of Iowa City as part of the Foundations of Clinical Practice II course.
- Administered the **Community-Based Primary Care Clerkship**, a four-week required course for 125 third-year medical students emphasizing community health services in designated Iowa communities.
- Arranged **housing** for medical students, PA students, and UIHC residents in community settings.
- Processed and tracked 19 requests for **adjunct appointments** for community-based preceptors.
- Arranged 64 faculty speakers providing 99 teaching visits for the **UICCOM Visiting Professor Program** at eight community-based residency programs.

# Community Services Division

- Provided recruitment assistance and related services to 123 communities in 84 of Iowa’s 99 counties through the **Medical Practice Development Program**.
- Advised and consulted with numerous providers and administrators regarding their **practice management needs**, including practices in Ankeny, Boone, Cedar Rapids, North Liberty, Mount Pleasant, Sioux Center and Sumner.
- Assisted 62 physicians regarding **practice searches**, including CV preparation, practice preferences, Identification of practice opportunities, and employment agreement consultations.
- Published OSCEP’s **2011-2012 Iowa Medical Practice Opportunities Directory** providing information on a total of 347 practice openings in family, emergency medicine, general internal medicine, hospital medicine, obstetrics, pediatrics and psychiatry. A similar directory was published for physician assistants and advanced registered nurse practitioners listing 129 opportunities.
- Administered the **Rural Physician Support Program** through which physicians in training have covered rural practice 325 times involving 578 weeks of physician absences since 1994.
- Critiqued employment **contracts** for 18 residents and fellows who were considering their first practice after completion of training. Twenty-three (23) other physicians received guidance on specific contract issues.
- Organized and facilitated periodic meetings of UI-affiliated special interest groups, including the Iowa Family Medicine Residents Council, the Community-Based Residency Program Directors, Program Administrators, Residency Coordinators and Behavioral Science faculty.
- Coordinated the **Fringe Benefits Plan of UI-Affiliates**, covering 3 UI-Affiliated Regional Medical Education Centers.
- Administered the **UI-Affiliated Medical Liability Insurance Plan** for UI-Affiliated Regional Medical Education Centers in Cedar Rapids, Davenport, Sioux City and Waterloo. Risk management reduced premiums by 9% and enabled shared dividends of over \$100,000.

# Tracking Systems/Workforce Analysis

- Maintained current content of the **Iowa Health Professions Inventory (HPI)**, a longitudinal database tracking Iowa’s health professions workforce. The following table summarizes Iowa’s health professions workforce as of December 31, 2011, the most recent annual benchmark.

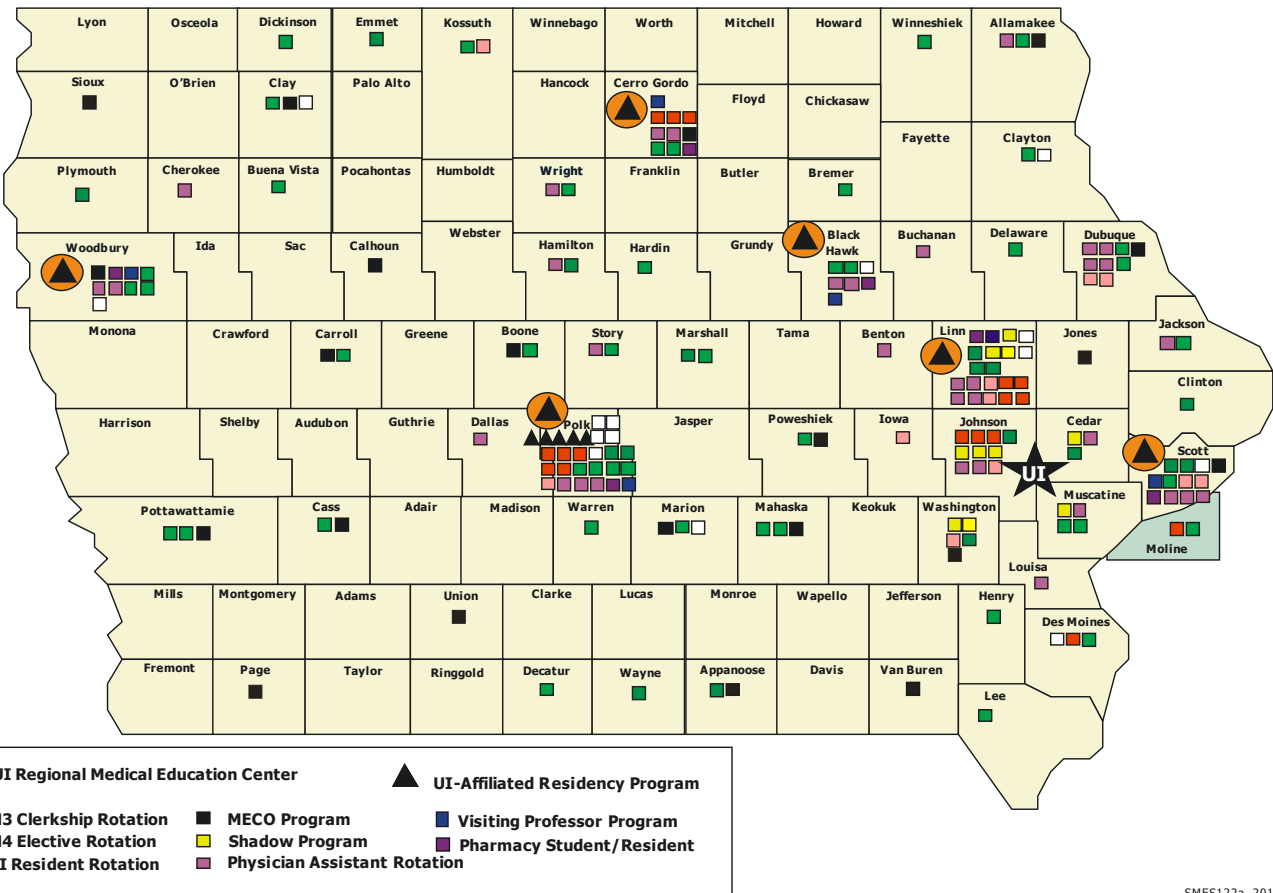

- Conducted the annual statewide inventory of **Visiting Consultant Clinics (VCC)** and produced the 2012 Annual VCC Report. Forty-four medical specialties provided service in 114 Iowa communities for a total 1,121 clinic days.
- Maintained current content of the **Resident Information System**, a longitudinal database tracking Iowa’s 1,635 family medicine graduates at their practice locations in Iowa and 48 other states.
- Directed work on **software enhancements** for the Iowa Health Professions Inventory, Residency Information System, Visiting Consultant Clinic Tracking System and the Visiting Professor Program database.
- Produced workforce data sets for use in **presentations** given to community leaders, professional societies, educational institutions and state agencies.
- Supervised the development of a new **Community-Based Clinical Education Programs Tracking System** to document both the clinical experiences of individual learners and the teaching effort of community-based faculty.
- Generated more than \$45,000 in **data sales** to help support OSCEP tracking systems and data services.
- Provided maintenance and technical support for the **OSCEP website**.
- Produced **data, graphics and tables** for routine and special **reports** serving internal and external clients on fifty-five projects.
- Coordinated meetings and deliberations of state-level **advisory committees** for each of the health professions represented in the Iowa Health Professions Inventory.
